This qualification can be studied over 6, 12 or 18 months through day release or evening classes. The duration will depend on starting point and optional units chosen. Please note, to complete the qualification over 6 months you will be required to study for multiple units at once via day release.

Financial Statements, Management Accounting: Budgeting and Management Accounting: Decision and Control must have been completed before attempting the Synoptic course.

It is advised that Business Tax and External Audit are studied after completing Financial Statements for Limited Companies as these units will assume knowledge on the structure of company accounts.

You can commence your studies with any of the following units; Financial Statements for Limited Companies, Management Accounting: Budgeting, Management Accounting: Decision and Control, Credit Management and Control, Cash and Treasury Management or Personal Tax.

Mandatory units will run as day release classes every 6 months and in the evening every 12 months, optional units will run once every 12 months.

You will need to register with AAT for the Level 4 Professional Diploma in Accounting Qualification - current price £150 payable to AAT.

Please note, the last registration date with the AAT for the AQ2016 syllabus is 31st January 2022. You must become a member of the AAT prior to this date to enable you to continue with the current syllabus. From 1st February 2022, you will only be able to register for the new AAT AQ2022 syllabus.
